## 1. UNDERTAKINGS OF THE ARTIST

1. THE ARTIST agrees to provide Artist's Services at such times and at such locations and in a professional manner, as listed in this document.
2. THE PRESENTER and THE ARTIST agree that this is a professional event and as such, a professional manner is expected from both parties.
3. THE ARTIST agrees to assist in promoting the event, publicizing the event to their sphere of contacts.
4. THE ARTIST agrees to be documented on video and still photography for the purposes of documentation.

## 2. UNDERTAKINGS OF THE PRESENTER

1. THE PRESENTER will endeavor to maintain a reasonable schedule for this project.
2. Provide the Venue for performance(s) that is safe and in good order.
3. Provide limited technical equipment, upon mutual agreement between Producer and Artist.
4. Enters this agreement providing indemnity for the artist (i.e. Liability, loss or damages. **[TO BE AGREED UPON BY BOTH PARTIES]**)

## 3. PHOTOGRAPHY

THE ARTIST hereby agrees that THE PRESENTER has the right to reproduce in any manner whatsoever any photographs or short audio or video recordings heretofore made of performances for promotional purposes.

THE ARTIST releases THE PRESENTER from any liability arising out of its use of my name, likeness and/or photograph and shall not assert any claim against THE PRESENTER arising to of such.

THE ARTIST hereby grants to THE PRESENTER the unrestricted right throughout the world and in perpetuity, to use THE ARTIST's name, voice, likeness and biographical data in connection with production, distribution, exhibition, advertising, and use of the Production in any media and by any means as the Producer, in its sole discretion, may deem appropriate.

## 4. MARKETING

THE PRESENTER shall be responsible for the marketing, media relations and/or outreach of the Engagement.

- 4.1 The THE PRESENTER will list in the digital house programs the complete ARTIST company and financial credits.
- 4.2 THE ARTIST shall furnish to THE PRESENTER the promotional information and materials. Still photography and video clips provided by the ARTIST may be altered for marketing purposes. Articles will be used to promote both THE ARTISTS work and the event.

## 5. ARTIST FEES

**7. CONSTRUCTION**

This Agreement constitutes the entire understanding between the parties, and may not be amended except in writing signed by both parties hereto. This Agreement shall at all times be interpreted pursuant to the laws of the Province of Alberta and shall be binding upon the executors, administrators and successors of the parties.
